Course Description: This one credit seminar provides professional development opportunities for PhD students in HSMP, including inside perspectives on research, careers, and management of academic life.

Class Format: Our seminars will include a mix of five elements: (1) guest speakers: research presentation and discussions by faculty members from the division, faculty from elsewhere at OSU, alumni, and PhDs in non-academic careers, (2) professional development discussions, (3) works-in-progress discussions focusing on one student's work each session, (4) communication practices through a short presentation of a health services research topic targeting a layperson audience, and (4) one-on-one meetings for each student with Dr. Xu or (in the case of Dr. Xu's advisees) other HSMP faculty members. Students will help determine the agenda of topics for the semester. Course meetings will be led by Dr. Xu.

All students are required to attend each seminar on each meeting day. For those in the first or second year of the program, each student (other than Dr. Xu's advisees) is required to sign up for two one-on-one meetings as instructed by Dr. Xu. Dr. Xu's advisees are required to have at least two one-on-one meetings with other HSMP faculty members during the semester; Dr. Xu can assist in arranging this. Students in third year and beyond should have at least one one-on-one meeting with Dr. Xu each semester and are highly encouraged to keep meeting with other HSMP faculty members.

The class meets in person. The students are encouraged to wear a mask to class if you are not feeling well. Alternatively, in the case of illness, the student is welcomed to attend the class via Zoom if you inform the instructor before 9am on class day.

Course Objectives & Core Competencies

The core objective of this course is to advance students' understanding of the research methods and professional skills involved in research and careers in Health Services Management and Policy. Guest speakers will contribute to this core objective and advance your understanding of specific research areas within the field. Works-in-Progress sessions will allow you to apply lessons we are learning and deepen your mastery of research methods and academic writing skills.

Together, the central activities of the course will contribute to building the following HSMP PhD Competencies:

- **PHD 2**. Synthesize and critique existing literature in student's area of specialization to identify gaps in the evidence base and justify their importance for public health.
- **PHD 3**. Apply relevant theories and conceptual models to inform and ground research design and interpretation.
- **PHD 4.** Formulate hypotheses, plan and conduct a research study using appropriate research methods, and ethical approaches.
- **PHD 5**. Analyze data and prepare an original manuscript, suitable for publication, summarizing the results and interpreting the findings from a research study.
- **PHD 6.** Communicate in writing and orally a research study's purpose, methods, results, limitations, conclusions and public health relevance to both informed and lay audiences.
- **PHD 8**. Critically assess relevant health management and policy theories and concepts as applied in health systems research.

Text/Readings: As assigned within the month prior to each class meeting.

Grading: In this doctoral-level seminar, your entire grade will be based on your participation. Participation includes completing assigned readings and preparing as instructed for class, preparing your own materials when you are presenting, attending each session and participating actively in all class discussions. This seminar will be graded on a pass/fail basis.

Attendance: Class attendance is mandatory. If you *must* miss a session or portion of a session, you are required to notify the professor in advance via email.

Guidelines for Classroom Discussions:

• Criticize ideas, not individuals.

- Listen actively and with an ear to understanding others' views. (Don't just think about what you are going to say while someone else is talking.)
- Commit to learning, not debating. Comment in order to share information, not to persuade.
- Avoid blame, speculation, and inflammatory language.
- Allow everyone the chance to speak.
- Avoid assumptions about any member of the class or generalizations about social groups.
- Do not ask individuals to speak for their (perceived) social group.
